Resolved the issue regarding the capture of the Item Master Standard Style and Color Descriptions, when linking a Sales Order Detail, instead of the manually entered Sales Detail Style and Color Descriptions when the Company Information "Allow Item Description Changes in S/O" control is activated.

Resolved the issue regarding incorrectly blanking out the customer number when attempting to create a new customer from the Sold to Customer Search of an existing order.

Authorize Transfer

Resolved the issue regarding display of an "Access Denied" error if the user does not have location permission to the transfer from location.

Note: There is no location restriction to execute the "Authorize Transfer" transfer.

Sales Order Ticket

Resolved the issue regarding the random printing of additional blank pages with the ticket heading and no details for a Sales Order with a large number of detail lines.

P/O Wizard

Resolved the issue regarding the capture of the Item Master Standard Style and Color Descriptions, when using the P/O Wizard, instead of the manually entered Sales Detail Style and Color Descriptions when the Company Information "Allow Item Description Changes in S/O" control is activated.

WIRELESS WAREHOUSING

Item Locator

1) Resolved the PDA issue preventing manual entry of the Style or Color or Roll/Dye Lot within the item search criteria.

2) The item search criteria was changed to allow scanning or entry of just the Roll/Dye Lot to display a list of material matching the search criteria.

Note: Scanning or entry of the Style and/or Color and/or Roll/Dye Lot are allowed.
